





ACT Seniors Card – Application form

The ACT Seniors Card is part of an Australia-wide initiative jointly supported by the ACT Government and Council on the Ageing (ACT). Each state and territory has a Seniors Card Scheme and some reciprocal arrangements are in place for using your card in other states and the Northern Territory. The scheme recognises the valuable contribution of older people in their local community.

An ACT Seniors Card provides access to a range of business discounts and ACT Government concessions, including travel. The ACT Seniors Card provides free off-peak travel on Transport Canberra services. Seniors aged 70 or over who hold an ACT Seniors Card are entitled to free travel on Transport Canberra services.

An ACT Seniors Card is available to permanent residents who live in the ACT, meet the age eligibility and are not in paid employment for more than 20 hours per week.
